WE EDUCATED 65,000 PEOPLE IN 2017 ABOUT THE HOLOCAUST AND THE NEED TO RESPECT AND STAND UP FOR THE RIGHTS OF OTHERS IF WE ARE TO PREVENT FUTURE DISCRIMINATION, HATE CRIMES AND GENOCIDE. MANY OF THESE PEOPLE WERE STUDENTS WHO VISITED THE HMC WITH MIDDLE SCHOOL, HIGH SCHOOL AND UNIVERSITY GROUPS AND WHO WERE EDUCATED THROUGH GUIDED TOURS FOLLOWED BY PRESENTATIONS BY LOCAL HOLOCAUST SURVIVORS. OTHERS TOURED THE HMC WITH THEIR FAMILIES, MADE USE OF OUR LIBRARY ARCHIVE, OR ATTENDED ON-OR OFF-SITE PROGRAMMING WE PRESENTED. THESE VISITORS CAME FROM THROUGHOUT THE STATE, AS WELL AS FROM OHIO, INDIANA AND ONTARIO, WITH THE MAJORITY OF THEM FROM SOUTHEASTERN MICHIGAN, AND THEY REFLECT THE DIVERSE RACIAL AND RELIGIOUS COMPOSITION OF THIS REGION.

4b (Code:) (Expenses \$ 337,070. including grants of \$) (Revenue \$) IN 2017, OUR EDUCATIONAL INITIATIVES INCLUDED TEACHER TRAINING, COMMUNITY OUTREACH, AND THE KAPPY FAMILY ANNE FRANK ART & WRITING COMPETITION. THE COMPETITION WAS PILOTED FOR OAKLAND COUNTY STUDENTS ONLY AND WAS EXPANDED IN FALL 2017 TO INCLUDE HIGH SCHOOLERS FROM MACOMB AND OAKLAND COUNTIES. IN 2018, THE CENTER HIRED A NUMBER OF HIGHLY EXPERIENCED AND QUALIFIED STAFF TO GREATLY EXPAND THE EDUCATION DEPARTMENT'S TEACHER TRAINING INITIATIVES, WITH A GOAL OF TRAINING 500 TEACHERS IN 2018. TRAININGS TAKE PLACE BOTH IN-HOUSE AND ACROSS THE STATE AND ARE CUSTOMIZED TO MEET THE NEEDS OF THE INDIVIDUAL SCHOOL DISTRICTS. THE GOAL IS TO EMPOWER TEACHERS TO USE THE LESSONS OF THE HOLOCAUST TO HELP STUDENTS UNDERSTAND THE DANGERS OF UNCHECKED HATRED AND TO LEARN THAT THEIR INDIVIDUAL DECISIONS MATTER.
